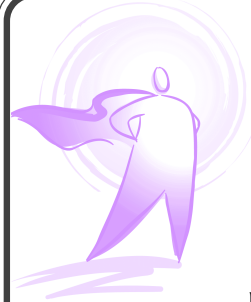
Jim Myers, of WBVR Radio, interviewed Tom Glover during a live broadcast from the Western Regional Kickoff.
